

# **THE GLOBAL MOVEMENT “WORLD MAP” REGULATIONS**

## **1. GENERAL PROVISIONS**

1.1. This Regulation defines the procedure for organizing and holding festivals (hereinafter referred to as the Festival) within the framework of the Global Movement “World Map” (hereinafter referred to as the Movement).

1.2. The “World Map” Festival in each host country will consist of events consisting of concert performances in the official language of the participating countries. The duration of the Festival in each country is no more than 7 days with an interval of 5 days for arrival in the next country.

1.3. The expected total duration of the Global movement “World Map” program in all the countries of the world is eight years.

1.4. Information about the course of Festivals within the Movement is posted on the official website of the Movement [www.world-fest.com](http://www.world-fest.com), in the information and telecommunications network of the Internet and other mass media.

1.5. The organizer of the Global movement “World Map”, represented by the “Sokol” Foundation for Social and Cultural Programs, acts in accordance with this Regulation and forms the Organizing Committee, which determines the order, time and venue of the Festival events.

1.6. For participation in Festivals, the registration fee for the benefit of the Organizing Committee of the Global movement “World Map” is not charged.

1.7. Each country participating in the Global movement “World Map” creates its own organizing committee for the preparation and holding of the “World Map” Festival on its territory.

1.8. For the “World Map” Festival, the host country-participant independently chooses a stage platform, using its technical capabilities (light and sound equipment, dressing rooms for artists, territory protection, etc.).

1.9. Travel, accommodation and meals for participants, accompanying persons and delegations to the venue of each Festival is carried out at the expense of the sending party (member countries of the Global movement “World Map”).

1.10. The organizing Committee of the “World Map” Festival of the host country member is entitled to recommend all the participants and guests of the hotels for their stay during the events, conduct your advertising campaign, to attract sponsors (except alcohol and tobacco products) to organize events on its territory without coordination with the organizing Committee of the Global movement “World Map”. Partners can be state, non-state, public, commercial, non-profit organizations at all levels that provide organizational, financial, and informational support for events.

1.11. Each country participating in the “World Map” Festival shall independently select the artists to perform in this or that country.

1.12. In the world festival route, all performers of concert numbers perform only once, since the program of each event must be updated.

1.13. The rules and scenario of the Festival in the host country are agreed and approved by the Organizing Committee of the Global movement “World Map” and the Organizing Committee of the “World Map” Festival of the host country jointly no later than 2 months before the event.

## **2. GOALS AND MISSION OF THE MOVEMENT**

### Goals:

- Assist in termination of military conflicts, terrorism, and extremism.
- Enhance security of the growing generation.
- Preserve the cultural and historical heritage of the world’s nations.
- Development of international relations in all spheres of life of the world community.
- Formation of a careful attitude to the natural resources of the planet.

### Mission:

- Present and popularize national cultural traditions of the countries participating in the Global Movement “World Map” and their creative achievements.
- Attract the public attention to the environmental policy objectives, modern environmental problems of world civilization and increase responsibility taken by each individual of the community for the destiny of nature and people.
- Promote the ideas of creative and constructive work in accord with nature.
- Enhance the intensity of project, research, and practical activities to improve ecological quality of the environment.
- Promote healthy lifestyles.
- Promoting positive images of countries in the public consciousness through film, television, press and radio, aimed at the ideology of good, peace and creation.
- Build up the ties of friendship between countries.
- Present best works of the global arts.
- Establish a common cultural space, and strengthen the interethnic concord.

## **3. PROCEDURE AND DEADLINES FOR SUBMITTING APPLICATIONS**

The “World Map” Festivals within the framework of the Global Movement “World Map” will be held in several stages.

### **STAGE I**

- Acceptance of applications from States for participation in the Global Movement “World Map” until **April 20, 2021** inclusive. Applications are accepted by e-mail [world-fest@mail.ru](mailto:world-fest@mail.ru) or to the postal address: “Sokol” Foundation for Social and Cultural Programs, the Kremlin in Izmailovo, 73zh, Izmailovskoe shosse, Moscow, 105187, Russia.
- The application form is Appendix No. 1 to this Regulation.

- Together with the application, the participating country sends a video about its country of no more than 120 seconds. The video should contain a greeting from children in the official language of the country with the words: “(The name of the country) sends greetings to the whole planet. We are for a world without borders!”
- In response to the application, the participating country will receive a notification confirming its participation in the Global Movement “World Map”.
- The list of countries participating in the Global Movement “World Map” will be posted on the official website [www.world-fest.com](http://www.world-fest.com) **April 21, 2021**.

## STAGE II

- **On June 1, 2021, at 15:00 Moscow time**, a draw will be held to determine the sequence of Festivals in the countries participating in the Global Movement “World Map”.
- The event will be held in a TV studio with a live broadcast on the website [www.world-fest.com](http://www.world-fest.com) and it will be a video recording of the greeting of children from Russia in Russian with subtitles in English, followed by the drawing of lots for applications from states. Each country has the right to translate the live broadcast into its own state language.
- The event will be held without the presence of spectators in the hall, with the exception of experts sent by a member country of the Global Movement “World Map”.
- After the draw, each participating country makes preparations for the Festival to be held on its territory.

## STAGE III

- The “World Map” Festivals will start in **June 2022** according to the world festival route set by the draw.
- **No later than 4 months** before the event, the host country-participant provides the Organizing Committee of the Global Movement “World Map” with presentation materials in its official language: a video about the country of no more than 4 minutes and a video with brief information about the artist and an announcement of the creative program of no more than 4 minutes, indicating which country the artist is going to.
- In turn, the Organizing Committee of the Global Movement “World Map” sends to the Organizing Committee of the Festival of the host country the relevant presentation materials, a list of artists and creative groups with their concert numbers of all participating countries for the Festival in the host country.

## 4. GENERAL REQUIREMENTS

- 4.1. The showmasters onstage of the Festival shall be children selected by a participating country holding the event.
- 4.2. The age of Festival participants must not exceed 16 years.
- 4.3. The artist's nationality does not matter. A performer may represent a country, while he or she is not its citizen.
- 4.4. The concert item must demonstrate the ethnic characteristics of the participating country and be performed in its official language.

4.5. The concert item of the participating country should last no more than 4 minutes and can be multi-genre.

4.6. There can be an unlimited number of participants on the stage, depending on the parameters of the stage platform. The Organizing Committee of the Festival of the host country-participant informs about the parameters of its stage platform in advance.

4.7. Use of obscene words as well as taking provocative actions in the musical works to be performed shall not be permitted.

4.8. Use of a voice phonogram shall be prohibited in the vocal genre.

4.9. A concert item presented to the Festival shall not be released or performed publicly before the event takes place.

4.10. Video messages of Their Excellencies of the Presidents of States and Their Majesties of the Kingdoms in support of the Global Movement “World Map” are welcome. Video materials are sent by e-mail [world-fest@mail.ru](mailto:world-fest@mail.ru) and will be posted on the official website: [www.world-fest.com](http://www.world-fest.com).

## **5. ADDITIONAL INFORMATION**

5.1. In connection with the measures taken to limit the spread of the COVID-19 coronavirus infection, and in the case of a ban on holding mass events in 2022, the “World Map” Festivals can be held in the online broadcast mode on telecommunications resources. In this case, the participating country conducts a tour of its country through television and talks about its culture and folk traditions. The performance of concert numbers in the online broadcast mode is carried out on stage with video shooting without the presence of the audience in the hall.
